ORDINANCE NO. 29

AN ORDINANCE OF THE MIDWAY CITY SANITARY DISTRICT, AMENDING SECTION 9 OF ORDINANCE NO. 15 AND REPEALING ORDINANCE NO. 23 TO THE EXTENT OF INCONSISTENCY, RELATING TO THE USE OF BINS.

THE BOARD OF DIRECTORS OF THE MIDWAY CITY SANITARY
DISTRICT, of Orange County, California, does ORDAIN as follows:

Section 1: That Section 9 of Ordinance no. 15, as added by Ordinance No. 23, is hereby amended to read as follows:

"Section 9 - Use of Bins."

- " (a) Whenever, in the opinion of the District Manager, it is convenient and necessary to the proper administration of this ordinance, he may require any person requesting service to utilize the refuse bin service provided by the District. All such bins shall be located on private property at a place satisfactory to the District.
- "(b) Bin service shall be mandatory for multiple dwelling units, consisting of ten (10) or more dwelling units, and serviced by the Midway City Sanitary District.
- " (c) The ratio of bins to the number of mulitple dwelling units shall be a minimum of one (1) for every ten (10) dwelling units based upon twice per week service; provided, however, that for good cause as determined by the District Manager, a minimum of one bin for every twelve (12) units may be allowed, based upon twice per week service.
- "(d) Notwithstanding the provisions of subsection (c) of this Section, a sufficient number of bins shall be provided in multiple dwelling unit complexes, even if in excess of the minimum number established in said subsection (c), so that there will be a maximum of three hundred (300) linear feet from the access door of any dwelling unit receiving bin service and the nearest bin.
- " (e) As used in this Section, "Multiple Dwelling Units" include apartments; any other rental units, a single parcel; condomeniums; townhouses; and mobile home parks."

Section 2: That Ordinance No. 23, and all Ordinances, and Sections thereof, inconsistent herewith be and

the same are hereby repealed to the extent of such inconsistency and no further.

Section 3: The Secretary of this District is hereby authorized and directed to cause a certified copy of this Ordinance to be published in a newspaper of general circulation and to be posted in three public places within the District.
