REGULATION ORDINANCE OF THE

GENERAL REGULATION ORDINANCE OF THE MIDWAY CITY SANITARY DISTRICT, OF ORANGE COUNTY, CALIFORNIA, AMENDING SECTIONS 1 AND 2, AS AMENDED, OF GENERAL REGULATION ORDINANCE NO. 1 OF SAID DISTRICT; AMENDING SECTIONS 4 AND 9, AS AMENDED, OF GENERAL REGULATION ORDINANCE NO. 3 OF SAID DISTRICT.

THE GOVERNING BOARD OF THE MIDWAY CITY SANITARY DISTRICT, of Orange County, California, does ordain as follows:

Section 1: That Section 1, as amended, of General Regulation Ordinance No. 1 of the Midway City Sanitary District be, and the same hereby is, amended so as to read as follows:

"Section 1: The Governing Board of the Midway City Sanitary District shall hold a regular official meeting of said Board at 7826 Westminster Boulevard, Westminster, Orange County, California, on the first Thursday of each month at the hour of 8:00 o'clock p.m."

Section 2: That Section 2, as amended, of General Regulation Ordinance No. 1 of the Midway City Sanitary District be, and the same hereby is, amended so as to read as follows:

"Section 2: Special meetings of the Governing Board of said District may be ordered at any time by the presiding officer of the Governing Board, or by a majority of members of the Governing Board, by delivering personally or by mail, written notice to each member of the legislative body, and to each local newspaper of general circulation, radio or T-V station, requesting notice in writing. Such notice must be delivered personally or by mail at least twenty-four hours before the time of such meeting as specified in the notice. The order shall specify the time and place of the special meeting and the business to be transacted. No other business shall be considered at such meetings by the legislative

body. Such written notice may be dispensed with as to any member of the Governing Board who, at or prior to the time the meeting convenes, files with the Clerk or Secretary of the Governing Board a written waive of notice. Such waiver may be given by telephone. Such written notice may also be dispensed with as to any member of the Governing Board who is actually present at the meeting at the time it convenes."

Section 3: That Section 4, as amended, of General Regulation Ordinance No. 3 of the Midway City Sanitary District be, and the same hereby is, amended so as to read as follows:

"SECTION 4: It shall be unlawful for any person, firm or corporation to make or attempt to make, or cause to be made, any connection with the main sewer lines of Midway City Sanitary District of Orange County, California, without first having secured permit therefor, and having paid an application fee of Three Dollars (\$3.00). Permit to make such connection shall be granted upon application made upon blank forms furnished by the district, and in the manner as in such form prescribed, which application shall be filed with the authorized representative of the Sanitary Board of said district, together with the application fee of Three Dollars (\$3.00), and shall thereupon by the said authorized representative, be referred to the inspector of the Midway City Sanitary District of Orange County, California, who shall be authorized to issue a permit for making such connection. The fee so paid shall be deposited in the treasury of said district. All sewer connections and pipe lines laid in connection therewith must be under the supervision of the inspector of said district, and in conformity with the requirements and provisions relating to such connections prescribed by the Sanitary Board of said district.

"Permits will be issued only to persons, firms or corporations who have obtained a license to engage in the business of constructing sewers in the Midway City Sanitary District of Orange County, California. A permit shall not be assignable or transferable, or used to aid or abet any unlicensed person, firm or corporation in the performance of any such work or operation for which such permit was issued.

"For the purpose of carrying out the provisions of this ordinance, the Sanitary Board of Midway City Sanitary District of Orange

County, California, shall appoint an inspector, who shall be authorized to enforce such regulations as may be necessary to carry out the provisions of this ordinance, and who shall hold office at the pleasure of said Sanitary Board."

"The \$3.00 permit fee hereinabove set forth shall entitle the applicant to not to exceed three inspections of the work by the District inspector. In the event additional inspections are required before the work is approved, there shall be paid an additional fee of \$3.00 for each additional inspection so required."

Section 4: That Section 9, as amended, of General Regulation Ordinance No. 3 of the Midway City Sanitary District be, and the same hereby is, amended so as to read as follows:

July W

"SECTION 9: Connecting sewers and house sewers shall be constructed of vitrified clay, tile, cast iron or such other materials as may be approved by the Governing Board of the District. All vitrified clay pipe and fittings shall conform in every respect with the requirements of the specifications for glazed vitrified clay pipe of the Clay Products Institute of California, Southern Division, said specifications being made a part of this ordinance. Cast iron pipe and fittings shall be of the grade known as 'standard' soil pipe."

Section 5: That all motions, resolutions and ordinances, and parts thereof, in conflict herewith be, and the same hereby, repealed to the extent of such conflict and no further.

Section 6: The Secretary of the Governing Board of this District shall certify to the passage of this ordinance and shall cause the same to be published once in the Westminster Herald, a newspaper of general circulation printed, published and circulated in the Midway City Sanitary District, of Orange County, California, and this ordinance shall be in full force and effect at the expiration of one week from and after the date of its final passage.
