ORDINANCE NO. 26

AN ORDINANCE OF THE MIDWAY CITY SANITARY DISTRICT OF ORANGE COUNTY, CALIFORNIA, IMPOSING SPECIAL USAGE FEES FOR SANITATION SERVICES ON PROPERTIES ANNEXED TO THE DISTRICT SUBSEQUENT TO JULY 28, 1981, AND ELECTING TO COLLECT SUCH FEES ON THE TAX ROLL.

WHEREAS, in the past, when the Midway City Sanitary District annexed real property to the District, said annexation would result in the imposition of a property tax on said property which would generate revenue needed by the District for the service of such property; and

WHEREAS, certain recently enacted sections of the California Revenue and Taxation Code require that, with respect to annexations occurring subsequent to July 28, 1981, the Midway City Sanitary District negotiate with the County of Orange and other affected governmental agencies with respect to the exchange of a portion of the annual property tax increment resulting from such annexed property; and

WHEREAS, said statutes further require that, prior to an annexation being finalized, resolutions must be submitted to the Local Agency Formation Commission by the District, the County of Orange and other affected governmental agencies containing an agreement regarding the exchange of property tax revenues, or else all annexation proceedings are terminated; and

WHEREAS, because the County of Orange has taken the position that it will not share any portion of the property tax increment from such annexed property with the annexing District, the Midway City Sanitary District, with respect to real property annexed subsequent to July 28, 1981, will realize no property tax revenue from such annexed properties; and

whereas, the Midway City Sanitary District cannot afford to provide indefinite continuous service to properties from which

it is deriving no property tax revenue to defer the cost of providing that service, and the District declines to operate the District at a financial loss; and

WHEREAS, dependance upon a portion of the property tax or the Special District Argumentation Fund to be allocated at the sole discretion of the County of Orange is deemed by Midway City Sanitary District as an unreliable source of revenue for DISTRICT operations and not in keeping with good planning and sound fiscal practices; and

WHEREAS, a refusal by the Midway City Sanitary District to annex property and provide service to properties outside the District boundaries will result in extreme hardship to owners of said properties; and

WHEREAS, the Midway City Sanitary District is willing to annex and provide service to properties outside the District if the owners of said properties agree to pay a special user fee, in addition to fees and charges required to be paid to the District prior to connection with the District mains and fees and charges required to be paid to the District by all users of its facilities, which special user fee is set forth in a Special Usage Permit Agreement and Restrictive Covenant executed by both the District and the owner of property proposed to be annexed; and

WHEREAS, since July 28, 1981, the Midway City Sanitary
District and owners of annexed properties have executed a number
of such Special Usage Permit Agreement and Restrictive Covenant
documents, which have been recorded with the County Recorder, and
the District has directly billed the property owners for the charges
imposed by said Agreements; and

WHEREAS, every property owner executing such Special Usage Permit Agreement and Restrictive Covenant agrees that the special user fee imposed therein may be collected on the tax roll in the same manner, by the same persons, and at the same time as,

together and not separately from, the general taxes of the Midway City Sanitary District and the County of Orange;

THE BOARD OF DIRECTORS OF THE MIDWAY CITY SANITARY DIS-TRICT, of Orange County, California, does hereby ordain as follows:

Section 1: Pursuant to the provisions of Health and Safety Code §§ 5471 and 6520.5, the following special user fee is hereby established for all property annexed to the Midway City Sanitary District subsequent to July 28, 1981:

A. A fee which is equal to three percent (3%) of the annual property tax increment from said property beginning with the fiscal year in which the annexation of said property is approved by resolution of the District's Board of Directors.

B. For the purpose of this Ordinance, the annual property tax increment is defined as that amount by which the property tax on said property has increased since the fiscal year immediately preceding the fiscal year during which the annexation of said property was approved by resolution of the District's Board of Directors.

Section 2: Pursuant to the provisions of Health and Safety Code §5473, the Board of Directors of the Midway City Sanitary District hereby elects to have said special user fees collected on the tax roll in the same manner, by the same persons, and at the same time as, together with and not separately from, the general taxes of the District and the County of Orange.

Section 3: Annually, the Manager of the Midway City
Sanitary District shall cause a written report to be prepared containing a description of each parcel of property subject to said special user fee, together with the amount of the special user fee applicable thereto.

Section 4: Annually, the Secretary of the Board of Directors shall cause appropriate notice of the filing of the report
