Section 1: That Section 1, as amended, of General Regulation Ordinance
No. 1 of the Midway City Sanitary District be and the same hereby is amended
so as to read as follows:

"Section 1: The Governing Board of the Midway City Sanitary District shall hold two regular official meetings of said Board at 14451 Cedarwood Street, Westminster, Orange County, California, during each calendar month on the first Wednesday and on the third Wednesday of each month at the hour of 6:00 p.m."

Section 2: That all motions, resolutions, and ordinances, and parts thereof, inconsistent herewith be and the same hereby are repealed to the extent of such inconsistency and no further.

Section 3: The Secretary of the Governing Board of this District shall certify to the passage of this ordinance and shall cause the same to be published once in the Westminster Herald, a newspaper of general circulation, printed, published, and circulated in the Midway City Sanitary District, of Orange County, California, and this ordinance shall be in full force and effect as of July 1, 1968.
