ORDINANCE NO. 45

AN ORDINANCE OF THE MIDWAY CITY SANITARY DISTRICT OF ORANGE COUNTY, CALIFORNIA, AMENDING SECTION 4 OF ORDINANCE NO. 44 REGULATING THE COLLECTION, TRANSFER AND REMOVAL OF SOLID WASTE

The Board of Directors of the Midway City Sanitary District of Orange County, California, **DOES HEREBY ORDAIN AS FOLLOWS:**

Section 1:

A new Section 4.3 is hereby added to Ordinance No. 44 of this District and the same is hereby amended to read as follows:

"4.3 It is unlawful, except with the consent of the District's General Manager, to collect, dump or deposit any rubbish on any property located within the District belonging to another either with or without the consent of the owner thereof. It is unlawful to establish or maintain a place for dumping rubbish in the District, or to collect, receive or dump any rubbish on one's own property, save and except such rubbish as shall reasonably accumulate upon one's own property in the reasonable and lawful use thereof, without the consent of the District's General Manager."

Section 2: Effective Date

This amendment to Ordinance No. 44 shall take effect one (1) week after it has been published once in a newspaper of general circulation within the District.
