ORDINANCE NO. 41

AN ORDINANCE OF THE MIDWAY CITY SANITARY DISTRICT OF ORANGE COUNTY, CALIFORNIA,

REPEALING ORDINANCE NOS. 29 AND 31 RELATING TO ELECTION CAMPAIGN

CONTRIBUTION CONTROL

WHEREAS, the Board of Directors has previously adopted Ordinance Nos. 29 and 31 relating to election campaign contribution control; and

WHEREAS, there are now state laws pertaining to limitations on campaign contributions in local elections because of the adoption of Proposition No. 73 in June, 1988; and

WHEREAS, the Board of Directors has determined that it is advisable, for the sake of consistency, to repeal the District's Ordinances pertaining to election campaign contribution control and to rely upon the state laws pertaining to this subject matter.

NOW, THEREFORE, the Board of Directors of the Midway City Sanitary District of Orange County, California, does hereby ordain as follows:

<u>Section 1</u>: Ordinance No. 29 and Ordinance No. 31 relating to election campaign contribution control are hereby repealed.

Section 2: This Ordinance shall take effect thirty (30) days after its adoption. The Secretary shall certify to the passage of this Ordinance and cause same, or a summary thereof, to be published within fifteen (15) days after adoption in a newspaper of general circulation, and to
