## ORDINANCE NO. 23

AN ORDINANCE OF THE MIDWAY CITY SANITARY DISTRICT ADDING SECTION 9 TO ORDINANCE NO. 15, RELATING TO THE USE OF BINS.

THE BOARD OF DIRECTORS OF THE MIDWAY CITY SANITARY DISTRICT, of Orange County, California, does ORDAIN as follows:

Section 1: That Section 9 is hereby added to Ordinance No. 15, to read as follows:

## "Section 9 - Use of Bins.

- "(a) Whenever, in the opinion of the Refuse Supervisor, it is convenient and necessary to the proper administration of this ordinance, he may require any person requesting service to utilize the refuse bin service provided by the District. All such bins shall be located on private property at a place satisfactory to the Refuse Supervisor.
- "(b) Bin service shall be mandatory for multiple dwelling units, consisting of ten (10) or more dwelling units, and serviced by the Midway City Sanitary District.
- "(c) As used in this section, "Multiple Dwelling Unit" includes apartments; any other rental units, consisting of two (2) or more units and located on a single parcel; condominiums; townhouses; and mobile home parks."

Section 2: That all ordinances, and sections thereof, inconsistent herewith be and the same are hereby repealed to the extent of such inconsistency and no further.

Section 3: The Secretary of this District is hereby authorized and directed to cause a certified copy of this Ordinance to be published in a newspaper of general circulation and to be posted in three public places within the District.
